#### **Our Mission**

AMS' Commodity Procurement Program—

- Support American Agriculture
- Provide food assistance to those in need domestically and overseas



#### How we meet our mission

- Commodity Procurement Program purchases U.S. origin food year-round:
  - Commodities for use—
    - Domestically for programs administered by the USDA Food and Nutrition Service
      - Schools, food banks, Indian Reservations and other household outlets
    - Internationally for programs administered by the U.S. Agency for International Development & the USDA Foreign Agricultural Service
  - Commodity-Related Services to support the above programs



#### Commodities

- Food for domestic food assistance programs (truckload quantities)
  - Proteins (Livestock, poultry, fish, & dairy)
  - Grain products (e.g., Rice, flour, pasta, cereal)
  - Oilseed products & tree nuts
  - Fruits & vegetables
- Food for international food assistance programs (railcar quantities)
  - Packaged grains, pulses & edible oils
  - Bulk grains & empty bags



### Commodity-related services

#### Service contracts for domestic include:

- Ocean transportation for offshore U.S. states and territories
- Lab testing for meat
- 3PL Warehouse and Transportation Services

#### Service contracts for international include:

- Vessel loading observation
- Marine cargo discharge surveys



### **Typical Contract Types**

- Firm fixed price
- Firm fixed price with Economic Price Adjustment

- Definitive Delivery
- Indefinite-Delivery, Indefinite-Quantity (IDIQ)

- For domestic: FOB destination
- For international: FAS vessel and other bases

  - Subscribe to email notices regarding commodity procurement
- Submit an application package at any time



### Vendor Qualification Requirements 1 of 4

#### Administrative requirements

- System for Award Management (SAM) registration
- Small business certifications (if applicable)
- Registrations and license (according to the commodity requirements)
  - FDA Food Facility Registration Number (all except "farms")
  - USDA Establishment Number (meat and poultry)
  - Perishable Agricultural Commodity Act (PACA) license
- Web Based Supply Chain Management (WBSCM) registration form



### Vendor Qualification Requirements 2 of 4

#### Technical requirements

- Company letter
  - Outlining history, experience, capacity, commodities to sell
- Three letters of reference
  - From satisfied customers
  - Demonstrates past performance record
- For nonmanufacturers
  - Supplier letter agreement from a manufacturer to supply you product
  - Complaint and dispute resolution proposal



### Vendor Qualification Requirements 3 of 4

#### Financial responsibility

- Financial Statement: Audited or reviewed financial statements, which include a balance sheet, profit and loss statement, statement of cash flows, statement of retained earnings and any notes to the financial statement.
  - Prepared independently
  - Prepared in accordance with U.S. GAPP
- Alternative 1: Performance Bond
- Alternative 2: Irrevocable Letter of Credit



### Vendor Qualification Requirements 4 of 4

#### Quality Assurance (QA) Requirements

- Food Defense Audit
- Plant Survey or Plant Systems Audit (PSA)
- Good Manufacturing Practices
- Additional QA requirements for specific products (see website and product specifications)
  - Livestock & poultry
  - Fresh Cut Produce
  - Fresh fruits & vegetables
  - Fluid milk
  - International bulk grain
