## **USDA** Tribal Consultation: Tribal Consultation Policies & Processes

March 9 & 11, 2021

TOPIC:

Presidential Memorandum on Tribal Consultation and Strengthening Nation-to-Nation Relationships (Jan 26, 2021)

SUMMARY:

On January 26, 2021, Joe Biden issued a presidential memorandum on consultation reaffirming President Obama's Memorandum for the Heads of Executive Departments and Agencies (Nov 5, 2009), which requires each agency to prepare and periodically update a detailed plan of action to implement the policies and directives of Executive Order 13175 - Consultation and Coordination with Indian Tribal Governments (November 6, 2000). President Biden's memorandum directs each Federal agency to consult with Tribes before developing a detailed plan of actions the agency will take to implement the policies and directives of Executive Order 13175, Consultation and Coordination with Indian Tribal Governments (Nov. 6, 2000), and to submit the plan to the Office of Management and Budget (OMB) by April 26, 2021. USDA will hold a consultation on March 9 and 11 to discuss and receive feedback on USDA's Departmental Regulation on Tribal Consultation, Coordination, and Collaboration as well as USDA's Consultation Action Plan.
