Codex Committee on Fish and Fishery Products (CCFFP)

The CCFFP was re-activated at the 43rd Session of the Codex Alimentarius Commission (November 2020) and will conduct its 35th session by correspondence, from September 20–October 25, 2021. The 35th Session of CCFFP will evaluate if the *Standard for Canned Sardines and Sardine-Type Products* (CXS 94-1981) could be amended to include the fish species S. lemuru (Bali Sardinella) in the list of Sardinella species under section 2.1. This is in accordance
