## Confirmation of Virtual Codex Alimentarius Commission (CAC) Meeting

## **Codex Alimentarius Commission (CAC)**

Members of the Codex Alimentarius Commission have endorsed the Codex Secretariat's plan to hold the 43<sup>rd</sup> Session of the Commission (CAC43) virtually and suspend the rules requiring an inperson meeting of the Codex Alimentarius Commission. The CAC43 meeting will take place in the format of four three-hour sessions from September 24-26 and again on October 12 and a fifth session with no set length on October 19, 2020 for the adoption of the report. The Codex Secretariat has circulated an invitation for CAC43 participants, which requires registration including the names, titles, and addresses of attendees using the online system included in the letter by the deadline on September 17, 2020.

## Codex Committee on Fats and Oils (CCFO)

**Work Not Being Initiated:** At CCFO26, the Committee agreed to establish an EWG on the List of Acceptable Previous Cargos. The Codex Secretariat recently sent an email and stated that since there were no proposals for new substances or removal of substances, the Chair of the EWG decided not to initiate an EWG for work ahead of CCFO27.

# Joint FAO/WHO Expert Committee on Food Additives (JECFA)

JECFA published its monograph on the residue evaluation of certain veterinary drugs created at the 88<sup>th</sup> meeting of JECFA, which took place in Rome from October 22-31, 2019. JECFA specifically considered residues of veterinary drugs in food at this meeting. The tasks before the Committee were to further elaborate principles for evaluating the safety of residues of veterinary drugs in food, establishing acceptable daily intakes (ADIs) and acute reference doses (ARfDs), and recommending maximum residue limits (MRLs) for such residues when the drugs under consideration are administered to food-producing animals in accordance with good practice in the use of veterinary drugs (GVP); to evaluate the safety of residues of certain veterinary drugs; and to respond to specific requests from the Codex Committee on Residues of Veterinary Drugs in Foods (CCRVDF).
